If the named student does not follow the terms of this contract, the inter-district/intra-district agreement may be immediately terminated and the student may be withdrawn from the school and district listed above. This decision is the responsibility of the principal/designee and that decision is final.

We, parent and student, also understand that by maintaining the terms of the contract, the school listed above will provide all of the opportunities and assume all of the responsibilities granted students residing within and attending this district.
